7:05 pm – Item 2 (15 minutes) – City of San Diego Senior Traffic Engineer Gary Pence has notified the Tierrasanta Community Council that the California Speed Trap Law (California Vehicle Code Section 40802) requires that the City survey the prevailing speeds on classified streets every 7 years in order to keep speed limits radar enforceable under the provisions of the law. The City recently surveyed Santo Road between Clairemont Mesa Blvd. and Portobelo Drive and the results indicate that the existing posted speed limit of 45 miles per hour for northbound vehicles can be changed to 40 miles per hour. The posted speed limit for the southbound direction will remain at 45 miles per hour. If the Tierrasanta Community Council disagrees with this proposed action, it has until November 18th to notify the City. **Tonight's action is to take action as appropriate.**
