Tonight's discussion will review the existing CIP projects already adopted for the Tierrasanta community, and to consider new ones, removing projects on the list(s), and prioritizing the list. Draft Minutes of Community Development Committee meeting 1 October 2012:

The Community Development Committee of the Tierrasanta Community Council convened on 1 October 2012 at 6:30 PM in room 3 of the Tierrasanta Recreation Center. Members present: Bill Reschke, Deanna Spehn, Tim Splinter, Scott Hasson, Lee Campbell, John Hopper, Kathy Warburton, Frank Tepedino, Misty Oto. Excused absence notification received for Eric Germain and Wayne Holtan. A quorum was present.

Agenda Item #1: Stop Signs for Antigua Blvd.

The CDC reviewed a proposal for adding stop signs to the Amaro intersection on Antigua Blvd. Residents submitted a petition supporting stop signs from all but one resident on this street between Clairemont Mesa and Santo Road. The CDC Committee heard input from residents Kathy Northfield and Heather Santana supporting traffic calming measures. Stop signs for this location have been proposed officially on three previous occasions, and denied by the city of San Diego. The street does not meet the criteria used by the city for stop signs and/or speed humps, specifically -1). it is classified as a collector street or higher in the Community Mast Plan Circulation Element, 2). the longitudinal grade of the street is greater than 5% (5 to 8.5% for Antigua), and 3). Antigua is a primary emergency access route per 2926 Fire Department map. The primary issue on Antigua is speeding drivers. However, the speed limit was lowered as a special favor many years back and would likely be raised under the basic speed law or if studied by city traffic engineers. Stop signs are not for speed control per federal/state/city highway codes. CDC discussed alternative traffic calming measures. Speed humps were previously denied by the city traffic engineers as stated above. Islands, narrowing measures, other signage, radar signs, and enforcement, were evaluated. CDC concluded that

the striping of parking guidelines from Clairemont Mesa to Santo and renewed enforcement were the best approach. The parking guidelines were previously painted on Antigua and worked pretty well. In about 20007 the street was slurry sealed multiple times and the parking guidelines/narrowing was never replaced. Northfield/Santana will insure residents support the replacement of painted narrowing of street and additional enforcement prior to TCC meeting.

MOTION: by Hopper, seconded by Hasson - CDC recommend to TCC for action at October meeting, 1) City should repaint parking guidelines the length of Antigua between Clairemont Mesa and Santo ASAP; 2) request enhanced traffic enforcement from San Diego Police Department for speed control; and 3) request the school prepare and distribute flyers to all students to alert parents to speed problem on Antigua.

The motion passed 9 to 0 with no abstentions.

CDC discussed potential future issues of interest to committee members. Quail Brush Power Plant - likely candidate for a full TCC public hearing. Kaiser Hospital site plans for Clairemont Mesa and Ruffin - presentation from Kaiser at next TCC meeting. Sale of Camp Elliot #3 school site. Bids were opened on 25 Sept with a single bid from a church intending to build a school there - no further details available at this time.

The meeting adjourned at 7:40 PM.
