6:38 pm Roll Call – Determination of Quorum by President Tim Splinter: Present - Tim Splinter, Derek Rotzinger, Deanna Spehn, Tom "TK" Keliinoi, Anthony Ferebee (arrived 6:50 pm), Loren Vinson, Bonnie Alexander, Sean Stafford for an initial quorum of 7 members, 8 members at 6:50 pm. New members voted on at this meeting include Steve Hasbrouck, Donna Jackson, Russ May and Rich Thesing (12 members). Absent: Joe Battaglia, Neill Thornton

Government Representatives:

<u>Fire Dept: Station 39</u>: Captain Jim Lang stated that the fire danger is extremely high and the Department is expecting a very active fire season. Arson inspectors are looking at the 6 fires that have occurred along the freeways surrounding Tierrasanta/Murphy Canyon in the last 2 weeks (I-15 & SR52). The emphasis this summer should be on basic safety at home including pool safety, making sure backyard grills are at least 3 feet from walls and fences, and the importance of learning basic CPR & Basic First Aid.

<u>Police Department</u>: Acting Lt. James Keck asked the community to report juvenile crimes and suspicious activity in the community. For general community concerns call Eastern Division at 858-495-7900. For emergencies call 9-1-1. The citywide contact for the Police Department is 619-531-2000.

<u>State Senator Joel Anderson</u>: Ed Smithrequested that the TCC support legislation sponsored by Senator Anderson to name a section of the State Route 15 between Miramar Road and Mercy Road the "Tuskegee Airmen Highway." The matter will be added to the July agenda.

<u>State Senator Christine Kehoe:</u> Deanna Spehnreported on the status of SB 1169 that would allow the City of San Diego to dedicate approximately 10,000 acres of city-owned open space including more than 800 acres in Tierrasanta.

<u>Assemblymember Marty Block</u>: Brian Beyersdorfupdated the TCC on legislation carried by Assemblymember Block including on public safety, education and veterans issues.

<u>County Sup. Pam Slater-Price:</u> Marc Regierdiscussed the pending vote by the Board of Supervisors on the annual budget including significant reserves. San Diego County reported 30 of the 300 snake bites statewide last year, and encouraged residents to be extra cautious.

Councilmember Marti Emerald: Marisa Berumenreminded the community that on June 28th at 9 am the Planning Commission will consider a request to initiate an amendment to the East Elliott Community Plan to change the zoning for approximately 10 acres from open space to industrial to accommodate the Quail Brush peaker plant. Councilmember Emerald had requested two extensions so that more public input could take place on this land use issue.

Item 1 – The TCC took action to fill existing vacancies on the Tierrasanta Community Council & Planning Group. Area 2 (At Large; expires March 2013) was formally declared vacant and declared to be an At Large position if no one from Area 2 comes forward at the July 2012 TCC meeting.

Approval of Minutes for April 18, 2012: Dan Lazzaro requested that the draft minutes for April 18, 2012 be changed to accurately reflect his statement. Approval of the amended minutes was moved by Keliinoi, seconded by Jackson and approved unanimously (11-0-1) with Rotzinger abstaining, including the following change for Dan Lazzaro: "... that the community has members on both sides of the issue and that the Council should not take one side or the other."

Item 2 Continued to July TCC meeting—Presentation by Neil Mohr, Allied Waste, regarding update to the Sycamore Landfill Master Plan that is going to the City of San Diego Planning Commission in July 2012.

Item 3–Eric Germain, President of the Tierrasanta Foundation, provided updates on the various projects underway by the Tierrasanta Foundation including the Bandstand, installation of commemorative pavers as part of the Bandstand, andthe June 30th 5K Fun Run. The City issued the Right-of-Entry permit for the Bandstand project the day of the TCC meeting.

Upon a motion by Thesing, seconded by Keliinoi, the Tierrasanta Community Council and Planning Group voted unanimously 12-0 on Wednesday, June 20, 2012 to endorse and support the Tierrasanta Foundation 5K and Fun Run to be held on Saturday, June 30, 2012, in the Tierrasanta Community Park.

Item 4– TCC Treasurer Derek Rotzinger reported on the clearing out of the Tierrasanta Community Information Center (TCIC). One final load ofincidental furniture and furnishings will be picked up that week. All utilities have been cancelled, the insurance will be cancelled once the space is entirely vacant. Rotzinger was commended by TCC members for all his work on closing down the TCIC within the 30-day notice period.

Item 5–Ferebee reported good turnouts at both the May 12th and June 2nd Concerts in the Park. There were an estimated 500 people at the May event and close to 600 in June. The next concert is August 18th featuring Y3K, and Ferebee encouraged people to come in their best 80's attire. Volunteers are needed for the August and September concerts. A concession stand is planned for the September 15th concert.

Item 6– 1) TCC President Splinter requested that a separate telephone line for use by the TCC President or other designated TCC member be approved. It was moved by May, seconded by Jackson and approved unanimously (12-0) to authorize a telephone line for the TCC that will be publicized on the agenda, TCC website, City website and TCC roster.
