Director Orr arrived; now 16 members present.

President Hasson asked if there were any persons interested in joining the TCC. Mr. Lee Campbell, a former TCC member, who was termed out in March 2010, and has not sat out a full year since he was termed out, asked to be appointed to finish the term of the area 7/at large Director, which ends on March 31, 2011.

Motion to Appoint Mr. Lee Campbell to the vacant Director position for the remaining 2 months of the positions term, by Director Zuckerman, 2nd by Director Rees.

Voted 13-1-1. Motion passes.

President Hasson voted NO as the bylaws needed to be reviewed due to term limits, less then 1 year and other issues concerning Mr. Campbell's eligibility to be appointed to the TCC as a termed out former member.
