Re: Overview of infrastructure projects in Tierrasanta – background for discussion

and ranking of Capitol Improvement Projects for Tierrasanta

I reviewed all the existing project lists that I could find on projects that have been discussed/proposed for Tierrasanta over the years. The Community Planners Committee is requesting that each of the community planning groups prioritize the CIP projects within the community.

Tierrasanta is considered to be an Urbanized (built-out) community, and although we had several million dollars in Developer Agreement Funds and Facility Benefit Assessment (FBA) funds and some Development Impact Fees (DIF) over the years, we have quite limited funds right now. Without a great deal of discussion, we most likely do not have funds adequate to pay for any major project. The Tierrasanta Community Council needs to request an accounting of whatever fund balances are available, and any restrictions on their use.

The "official" list the TCC has been asked to prioritize lists 4 projects:

- 1) Construct a comfort station/service building at the Mission Trails Regional Park Equestrian Staging Area \$496,000 total estimated cost; they claim to have \$218,000 more in funds than they need. The city wants to complete this project in March 2013. Technically MTRP is in our planning area, however the community has already given the park \$1 million and many believe that there are priorities within Tierrasanta itself.
- 2) Tierrasanta Community Park Sports Lighting project: the lights would be \$150,000 but the City has added extensive work on ADA to the project and we are \$453,876 short. The Tierrasanta Recreation Council voted unanimously not to proceed with this project because the ADA work would be done first, and there is not enough money to actually do the lights. The funds for the lights came from the Copperleaf project, the last housing project in Tierrasanta. With no more development proposed in Tierrasanta, there are no other potential sources of funds for Capital Improvement Projects. The Natural Resources & Culture Committee of the City Council voted to remove the project at its October meeting.
- 3) Electronic speed monitoring sign: project was completed in September 2011.
- 4) Balboa Avenue/Tierrasanta Blvd. Class II Bikeway was completed in August 2012.

Therefore, there is not much to prioritize.

Recommendations from other Tierrasanta groups

Tierrasanta Community Development Committee

The Community Development Committee received the petition submitted to the TCC earlier in 2012 requesting the installation of stop signs on Antigua to reduce speed. The CDC voted 9-0 on October 1, 2012, on the following motion: CDC recommend to TCC for action at October meeting, 1) City should repaint parking guidelines the length of Antigua between Clairemont Mesa and Santo ASAP; 2) request enhanced traffic enforcement from San Diego Police Department for speed control; and 3) request the school prepare and distribute flyers to all students to alert parents to speed problem on Antigua. The matter is on the TCC agenda for October 17, 2012.

Tierrasanta Foundation

The Tierrasanta Foundation's mission statement involves funding major infrastructure projects in the community, including relocating the existing fire station to another site within the community and constructing a larger facility that can accommodate three rigs (2 fire and 1 paramedic). The current fire station is not large enough to accommodate 3 vehicles and we lost the brush rig several years ago. However, a new Tierrasanta fire station is not on the city's list of priority fire stations.

The intent is that if the fire station moves, the library could be expanded onto the fire station site grow to the new ideal size in the city of 15,000 to 22,000 square feet. There are no city funds identified to fund such an expansion.

The Foundation's current project has been the construction of a permanent bandstand in Tierrasanta Community Park.

Tierrasanta Village of San Diego

Susan Deininger of Tierrasanta Village and others in the community would like to have Tierrasanta Village move into the Hex Building in Tierrasanta Community Park and use it as its headquarters, replacing the Tierrasanta Community Information Center that operated for 3+ years in Tierrasanta Town Center. In consultations with City Park & Recreation

Department staff, current city policy does not allow the city to issue a sole source Request for Proposals for such a use. The Hex Building is over 40 years old – it was the original sales office for Christiana Community Builders in 1971, then used as the administrative office of Tierrasanta Elementary Elementary School until the school was built, then moved to the northern end of Santo Road for several years where it was overtaken by bees, then moved to the current site of the Tierrasanta Library and cleaned up and used as a temporary library for several years, then when construction of the new library began, was moved to its current site at Tierrasanta Community Park. After its use as a library was over, it became the community's Recreation Center until the new Rec Center was completed in 1992. It is used as an overflow site for meetings in the park and for child care programs and other community uses. It requires extensive renovation.

Other nonprofits have requested to take over the facility over the years, but each time the city retained the Hex Building as a city facility.

Basic problem

Tierrasanta was the first Master Planned Community in the City of San Diego. Unfortunately, being the first, there were some oversights. For example, no land was set aside/zoned as potential church property. That meant that churches had to pay top dollar for residentially zone properties.

Although Tierrasanta was one of the first three areas in the city to vote to become a Maintenance Assessment District with 800+ acres of open space out of 2400 acres total in the community, not enough acreage was set aside for playing fields/active parks.

Over the years there has been interest in siting a Senior Center/Youth Center, Skateboard Park, Dog Park and a community garden in Tierrasanta, but there is no public land available to accommodate them. Tierrasanta is considered to be a "park poor community" based on our population and the ratio between population and existing park acreage.

Even with counting all the Joint Use Fields turfed playing fields at Serra High School, De Portola and Farb Middle Schools, and Kumeyaay, Tierrasanta and Vista Grande Elementary Schools, it is a challenge to accommodate all the sports leagues in the community.

The federal government is set to begin the sweep for unexploded ordnance on the military housing site on MCAS Miramar 2 miles east of Santo Road north of State Route 52. The San Diego Unified School District intends to construct 2 elementary schools on site, sharing administrative facilities, but the District does not intend to construct the schools until at least a few phases of housing is occupied. In the meantime, the final Environmental Impact Report for the project identifies Tierrasanta (not Murphy Canyon) schools as where the students from the 1600 housing units will attend. The District is proposing to move portables onto the elementary school sites to accommodate the children. That may affect the existing turfed fields at Kumeyaay and Vista Grande. According to the EIR, the majority of students generated by the new housing is anticipated to be elementary school aged.

There are no federal funds identified for constructing the schools, and it is the federal government's contention that it is a local responsibility to provide the funds for constructing new schools.

Recommendations from prior years

- 11. \$200,000: install security lighting at Villa Monserate Park
- 12. \$200,000: install security lighting at Villa Norte Neighborhood Park
- 13. \$200,000: install security lighting at Road Runner Neighborhood Park
- 14. \$1 million: improve lighting on Serra tennis courts (joint use)
- 15. \$500,000: improve right-of-way on Tierrasanta Blvd. from Colina Dorado to terminus

16. \$3 million: improve Tierrasanta Blvd. at eastern terminus as staging area for San Diego River
