Non-Agenda Public Comment

Anthony La Rocco, representing the American Youth Soccer Organization, noted that scheduled field closures would hamper pre-season training camps for his group and Pop Warner. August closures set training camp schedules back by at least two weeks. Mr. La Rocco requested an open dialogue with the various field users regarding the scheduling of these closures. Dan Foley noted that the closures were scheduled in concert with Tierrasanta Recreation Center staff. He will meet with Mr. La Rocco at a future date to discuss ways to improve communication regarding the scheduling process.

Sustainable Landscape – Turf Replacement Rebates

About 6,000 square feet of turf located along Tierrasanta Blvd. between Tambor, east to the SDGE Sub-Station has been targeted for removal—perhaps as early as March. Mr. Foley is meeting with Treebeard to select plant materials and discuss plans for the new irrigation system. Mr. Foley has applied for a City of San Diego turf reduction grant that would provide \$1.50 per square foot (up to 6000 square feet and \$9,000) for replacing turf grass with water wise landscaping.

Open Space

Canyonlands has found new funding to allow for the expansion of the Shepherd Canyon restoration areas. Eric Bowlby is working with staff for a new Right of Entry permit that will include all phases, current and proposed. Funding in addition to any that the MAD might provide for tree removal is also being sought.

Vector Control Projects Grant

Westin Solutions is obtaining the permits needed to start construction of three sites approved for remediation by San Diego County Vector Control. Two sites are located in the open space west of Santo Road. A third is located in the open space just off Calle de Vida at the head of North Rueda Canyon.

West Coast Arborists has completed their initial tree inventory. They mapped 1,122 trees with an estimated value of \$3.8 million dollars.

New Business

Lee Campbell reported that City of San Diego Brush Management would begin work in Scripps Ranch. They will continue on to Tierrasanta is there is enough money left in the budget.
