STAFF REPORT**

Landscape Maintenance

- Treebeard continues to provide landscape maintenance services in a timely manner and within budget. Turf fields are actively used by many User Groups.
- The parking islands at Tierrasanta Community Park where the palms were removed have been replanted with groundcover and toyon trees. Irrigation lines that were damaged have been repaired and are functional.

Tree Maintenance

- Tierrasanta Blvd center medians have been safety pruned from I-15 to Rueda Dr.
- Villa Norte Park tree trimming has begun.
- Safety pruning and unwanted tree suckers have been removed in OS area off of Villarrica Way.

Open Space Canyons

- On Saturday October 14th, the Friends of Tierrasanta cut and removed Eucalyptus re-sprouts in North Rueda Canyon of Seda Dr. They continue to treat invasive weeds.
- Weeds have been cleared in Lower North Shepherd Canyon from Villarrica Way to Antigua Blvd.
- Dishwasher Pond water has been filled and the level has been maintained.
- The Scour Pond in East Shepard Canyon has a potential construction improvement project in the planning phase. Glenn Christensen from Ahtna Construction will be present in November to speak to the Open Space Committee. A special meeting on November 8th has been scheduled.
- San Diego Canyonlands (SDCL) is on track with the Rueda Canyon palm removal project for December 2017.
- Mission Trails Regional Park has received bids from vendors and is waiting for a Purchase Order to proceed with the repair of the damaged pipe gate and wood pillars at the park entrance on Clairemont Mesa Blvd.

Miscellaneous

- An illegal homeless encampment behind Roadrunner Park near the field at Farb Middle School was notified and all trash and belongings removed.
- Solar panels installation at Tierrasanta Community Park continues in the upper parking lot. Testing and a final walkthrough is being scheduled.
- Water pipes have been installed on Clairemont Mesa Blvd. Construction and lane closures will continue in November.
- Storm Water is replacing a section of piping on Tierrasanta Blvd. near Colina Dorada Dr.
- Tierrasanta Community Park sports field lighting improvement project will begin soon. No additional information available at this time.
- Some playground structure equipment parts have been ordered. Repair will be conducted by the City of San Diego Community Parks.
