#### Landscape Maintenance

- Treebeard continues to provide landscape maintenance services in a timely manner and within budget.
- Center islands on Clairemont Mesa Blvd. are scheduled for irrigation upgrades.
- Lantana and Agapanthus have been planted and bare areas mulched to complete the center island on CMB from La Cuenta Dr. to Mollendo Blvd.
- New irrigation smart controller installed on Clairermont Mesa Blvd along with Hydrometer flow sensor.
- River rock installed on both center islands of Antigua Blvd. to complement the newly landscaped ends at Santo Rd. and Via Valarta.

# Tree Maintenance

- Trees have been safety pruned at Seda Dr. at the Renova Way trailhead.
- Safety pruning continues at various locations including Open Space overlooks and cul-de-sacs.

# **Open Space Canyons**

We're requesting to modify the funding for the Tierrasanta Trails Plan to be able to complete revisions to the biology report for the project. Updates will include updated field surveys for rare plants to be conducted during this field season and incorporation of the results into the report, along with additional revisions to the report which have been requested by the Agencies. An additional \$4,800 in funding is being requested in this Fiscal Year's budget to be able to complete this work. Preparation of a conceptual mitigation plan for the onsite Tier 1 mitigation is anticipated in the next Fiscal Year using budget that has already been approved for that purpose. - Friends of Tierrasanta in association with the San Diego River Kids Discovery Day have planted 40 coast live oak trees in Shepherd Canyon on Saturday March 10<sup>th</sup>. Irrigation drip lines were installed to help facilitate watering.
- Dishwasher Pond water has been filled due to the recent rains
- The pipe gate and wood posts at Mission Trails Regional Park Tierrasanta Entrance was replaced the week of March 19<sup>th</sup>. By March 26<sup>th</sup> it was damaged again.

# **Miscellaneous**

- GET-IT-DONE is a valuable tool for reporting many City issues. This form of reporting helps the issue get referred to the correct department to address. I encourage everyone to become familiar with GET-IT-DONE which is available on the City homepage at <u>www.sandiego.gov</u> or available as an application for smartphones.
- Tierrasanta Recreation Center roof repairs have begun and will continue in April.
- Villa Norte Park 2-5 play structure has been repaired and opened for use.
- Villa Monserate 2-5 play structure has been repaired and opened for use.
- Roadrunner Park slide has been closed due to unsafe surface cracks. New parts are on order and a work order has been submitted.
- Both Villa Norte and Villa Monserate playground sand areas have been deep tilled using the bobcat to relieve compaction and create a safer play surface.
