Landscape Maintenance

- Treebeard continues to provide landscape maintenance services in a timely manner and within budget.
- Irrigation main lines and laterals lines were repaired at Villa Norte Park and Villa Monserate Park.
- Irrigation upgrades on Tierrasanta Blvd. center median and rights-of-ways have begun.

Tree Maintenance

- Tree trimming and safety pruning continues at various locations including Open Space overlooks and cul-de-sacs.
- Trees have been safety pruned along lower Tierrasanta Blvd right-of-ways.
- Eucalyptus trees have been pruned in the open space along Calle Mariselda and upper North Shepard Canyon off Portobello Dr.

Open Space Canvons

- Dishwasher Pond water has been maintained at an adequate level.
- Mulch has been added to several Open Space overlooks and cul-de-sacs.
- Unexploded ordnance signs are being assessed and replaced as needed.

Miscellaneous

- GET-IT-DONE is a valuable tool for reporting many City issues. This form of reporting helps the issue get referred to the correct department to address. I encourage everyone to become familiar with GET-IT-DONE which is available on the City homepage at www.sandiego.gov or available as an application for smartphones.
- Tierrasanta Sports Field Lighting Phase II work has begun. Electricians are pulling wires into place. Materials are being delivered for install early October. The sports field irrigation has been suspended to allow the field to dry. A crane and other heavy equipment will be required to drive on the grass. Precautions are being taken to prevent unnecessary damage to the turf areas.
- Roadrunner Park slide has been repaired and is open for use. Finally! The installation required removing the existing concrete footing and installing a new one for the newly designed slide components. Work is complete and the slide issue here is closed.
- Engineered Wood Fiber (wood chips) at Roadrunner Park and Tierrasanta Community Park is on order. Installation is scheduled for October.

• All parks have had the playground sand rototilled in September to keep material loose and relieve any compaction.
