Landscape Maintenance

1. Treebeard continues to provide landscape maintenance services in a timely manner and within budget.
2. Irrigation main lines and laterals lines were repaired at Portobello pocket park and Calle Quintana pocket park turf areas.
3. Irrigation upgrades on a Tierrasanta Blvd. center median island and off Viacha Dr. has been completed.

Tree Maintenance

1. Tree trimming and safety pruning continues at various locations including Open Space overlooks and cul-de-sacs.
2. Fallen tree damage was removed off Antigua Blvd.
3. More tree work to be completed this month.

Open Space Canyons

1. Dishwasher Pond water has been maintained at an adequate level.
2. Mulch has been added to several Open Space overlooks and cul-de-sacs.
3. Unexploded ordnance signs are being assessed and replaced as needed.
4. Stinkwort has been treated and removed from Shepherd Canyon Trail between Villarica Way and Antigua Blvd.
5. San Diego Canyonlands has been cutting and removing both pampas grass and tamarisk from North Rueda Canyon.

Miscellaneous

1. GET-IT-DONE is a valuable tool for reporting many City issues. This form of reporting helps the issue get referred to the correct department to address. I encourage everyone to become familiar with GET-IT-DONE which is available on the City homepage at www.sandiego.gov or available as an application for smartphones.
2. Tierrasanta Sports Field Lighting Phase II work has completed. The sports field irrigation was suspended several times to allow the field to dry. A crane and other heavy equipment had to access the new light pole by driving on the grass. Precautions were taken to prevent unnecessary damage to the turf areas. With water, fertilizer, and some time the field will recover nicely.
3. Engineered Wood Fiber (wood chips) were blown in at Roadrunner Park and Tierrasanta Community Park. The playground areas are now full and safe.
4. FY20 Budget discussion is the main topic for The Tierrasanta Open Space Committee meeting on November 7, 2018.
