Landscape Maintenance

- Treebeard continues to provide landscape maintenance services in a timely manner and within budget.
- Mulch has been added to center island planter beds throughout Tierrasanta.
- The infield at De Portola is under construction to reduce the base spacing from 90 feet to 60 feet to allow for more little league baseball use. This project is separate from the Tierrasanta Maintenance Assessment District and funded without the use of MAD funds.

Tree Maintenance

- Tree trimming and safety pruning continues at various locations including Open Space areas.
- Open Space trees were safety pruned along the trail from Antigua Blvd. pocket park to East Shepherd Canyon Trail. Several dead trees and dieback was removed for fire safety.
- Open Space trees were safety pruned in North Rueda Canyon from Seda Dr. to Calle De Vida. Several dead trees and dieback were removed for fire safety.
- More tree work to be completed this month

Open Space Canyons

- Dishwasher Pond water has been maintained at an adequate level. Recent rains have helped to keep it full.
- Mulch has been added to several Open Space overlooks and cul-de-sacs.
- Unexploded ordnance signs are being assessed and replaced as needed.
- The invasive palm removal project by helicopter from Rueda Canyon took place in December. San Diego Canyonlands hired West Coast Arborists to cut and remove almost 300 palm trees. Total counts will be confirmed soon. Beginning on December 10th, all trees selected for removal were felled. This took over 2 weeks as just about all of them were at the canyon bottom with no accessible trail. On December 26th, 27th, and 28th the helicopter removal took place. Trail closures of both North Rueda and South Rueda Canyon were monitored to keep people out. Many of the Canary Island palms had to be divided into multiple sections to remove safely because of the weight. Staging areas were set up at both Farb Middle School and Calle De Vida open space. The removal took place, however the restoration of these areas will continue for several months.
