NOV. & DEC. ACTIVITIES IN TIERRASANTA

Landscape Maintenance

- Treebeard continues to provide landscape maintenance services in a timely manner and within budget.
- All Joint-Use fields have been fertilized and aerated. Playgrounds were rototilled as well.
- DG tracks at Farb Middle School & Vista Grande Elementary School have been filled in to match the mow curb height.
- The center island on Clairemont Mesa Blvd from Antigua Blvd to Santo Rd. is now complete with more plants and mulch added.
- The Tierrasanta Library officially reopened on November 25. The building itself had the restrooms remodeled, new flooring, a new outdoor patio, and about 1000' of additional space added on. Landscaping included the removal of several trees, new plantings in the planter boxes, and the addition of a living wall. This work was performed by the General Contractor. The Tierrasanta MAD will maintain all outdoor landscaping.

Tree Maintenance

- 10 trees were planted at Community Park: 4 crape myrtles, 3 Chinese Pistache, and 3 Brisbane Box (Tristania). Groundcover, river rock, and bird of paradise were also installed.
- More tree planting and tree pruning will continue in the early spring.

Open Space Canyons

- Friends of Tierrasanta continue their weekly cleanup. Eucalyptus suckers and re-sprouts are being removed in Rueda Canyon.
- Mustard and other annuals from the recent rains have been treated in Shepherd Canyon.
- Erosion control berms have been installed and repaired in Shepherd Canyon. The trail was also filled in. This work is ongoing after each season of rain.
- Brow ditches throughout Tierrasanta have been cleaned out in preparation for the rains. More are being cleared in the coming weeks.
