Activities in Tierrasanta (Nov-Dec)

Landscape Maintenance

- Treebeard Landscape, the contractor, continues to provide landscape maintenance services in a timely manner and within budget.
- Parks, playgrounds, and trails remain open during this latest COVID-19 closure.
- Villa Norte Park- Mulch was added to all newly planted trees and under the canopy of many others. This helps to provide organic matter, maintain moisture, and suppress weeds.
- Villa Monserate Park- ADA and playground construction continues on schedule.
- **Deportola School** Solar panel construction continues.
- **Tierrasanta Community Park** Christmas tree recycling has been moved to this park due to the solar panel construction and closure of Deportola Middle School.
- **Tierrasanta Blvd-** The Right-of-Way on the south side between Ducos Pl. and Rueda Dr. by the open space is now complete. Natives planted include: *Encelia californica, Rhus Integrifolia, Romneya coulteri,* and *Rhus ovata*. Several donated succulents were also planted in the ROW by Tambor Rd.

Tree Maintenance

Routine tree maintenance has continued throughout Tierrasanta parks, Joint-Use
Areas, center islands, right-of-ways, pocket parks, and open space areas. Priority in
the open space continues to be in areas where there are several targets. Such
areas include: trails, roadways, parks, schools, fence lines, and adjacent to houses.
Additionally, several dead trees have been felled or removed from open space
canyons to reduce the likelihood of fires.

Open Space Canyons

- **Shepherd Canyon** Five new trash cans and pet bag dispensers were installed between Santo Rd and Via Valarta.
- **Brush Management** The City of San Diego Brush Management Division has returned to complete areas not cleared during bird nesting season.

Miscellaneous

Your Dogs and City Parks- All dogs shall be maintained on a leash not to exceed 8
feet, including trails and canyons in all parks. Dogs benefit by being protected from
rattlesnakes, ticks, traffic and various other hazards and distractions. Also, poison
oak is spread from dogs to humans. Owners are always required to clean up after
their dogs.
