Info Item 2: Non-Agenda Public Comment: limited to 2-minutes each

Action Item 4: Discussion of the proposed city ordinance regulating short term residential occupancy. TCC to vote on recommending adoption to the office of City Council District 7.

- Vote is on Tuesday, February 23, 2021.
- Michael Ferrell: Concerns with vacation rental at 5772 Amaro Drive has become a nuisance. It is listed as a huge house for 12 people but no parties, however there is no enforcement. Tierrasanta is not listed in the ordinance, but there is a concern here.
- Joe Emanuelson: Property manager at 5772 Amaro Drive. Thinks that the complaints are over-exaggerated. Says he is happy to work with neighbors to continue to operate.
- Nathan Bates: Property owner at 5772 Amaro Drive. Feels that the rental is a benefit to the city and a personal benefit. He states that tourism and businesses get hurt without the balance of vacation rentals and hotels.
- Rich Thesing: Feels the ordinance is a good start because coastal areas have been affected and the idea of preserving residential areas and having enforcement is essential to preserve our neighborhoods.
- Jonathan Schwartz: Concern about passing fees along to tourists
- Emily Whittemore: Concern about passing fees along, but sees the need to have enforcement
- Chris Shamoan: Concern about passing fees along to tourists and doesn't see that Tierrasanta is largely affected like others who might not fall into that trouble category. Feels it would be fairer to only fine problem homes and not add a fee to everyone.
- Vince Delpidio: Concern that hiring 6 officers and spreading them over the entire city might not be enough resources. Renters in Tierrasanta will pay the fee but the calls may not be answered because they are too far.
- Rich Thesing: The officers will be spread thin and would prefer to district things out and let the towns make their own decisions.
- Don Chick: With 6 officers, most of the officers will be spending more time in the highly affected areas and people in the less affected areas will not get serviced.

- *Steve Muckle: Understands that a regulation will sometimes affect people who are not guilty but doesn't know a way to only target the offenders. Also has a concern about getting attention from enforcement officers. Likes to see a better framework to resolve conflicts like the ones which were mentioned on Amaro.*
- *John Adair: People have a different view of what's noisy, but people want to be comfortable in their own homes. Doesn't think it makes sense in Tierrasanta because we aren't a tourist attraction.*
- *Motion to support proposed ordinance in concept provided no Tier 3 licenses are issued in Tierrasanta by Vince Delpidio. Seconded by Emily Whittemore. Passed 7-3 as follows:*
 - *Yes: Mike Ogilvie, Emily Whittemore, Vince Delpidio, Rich Thesing, Don Chick, Steve Muckle, Mary Saxton*
 - *No: John Adair, Jonathan Schwartz, Chris Shamoan*

Action Item 5: Solicitation of TCC volunteers to participate in the use of earthquake safety kits provided by Ed Langmaid and funded by a grant from the Earthquake Country Alliance.

Ed Langmaid reminds us to drop, cover and hold on in case of earth movement. \$500 grant was received to help 55 Tierrasanta residents with an off the shelf device to help with earthquake hazards. San Diego is due for a significant earthquake, as it happens once every 150 years . . . and it has been 150 years! Non-structural household items are the concern in a significant earthquake. Chris Shamoan and Eileen Chatfield volunteered to be the beta testers on behalf of the Tierrasanta Community Council.

Action Item 6: Selection of TCC representative to Community Planners Committee.

Steve Muckle moved to replace Vince Delpidio with Emily Whittemore as CPC representative and add Vince Delpidio as an alternate alongside Steve Muckle, seconded by Vince Delpidio. Passed unanimously.

Action Item 7: Concerts in the Park policy for 2021.

While health restrictions may prohibit moving forward with the Concert in the Park, the advice is to continue with planning as if it can happen. Steve Muckle is open to ideas on how to resume the Concerts and is concerned with booking vendors then being pressured to move forward. Steve Muckle would like to discuss with the board the idea of not moving forward until there is a safe plan and real intention of moving forward. He and Jonathan Schwartz do not think it is a good example to lead the way with this type of event.

Steve Muckle made the motion to table the notion of planning the Concerts in the park until appropriate, seconded by John Adair. Passed unanimously.

Action Item 8: Finalize list of candidates in the March 2021 TCC election.

No new candidates expressed any interest other than those who are currently on the board who would be running for their own current seats. Vince Delpidio with check with a neighbor who was asking him questions about the Council. The ballot boxes will go out on March 6. Deanna will put together the ballots.
