- Green Bins and Organic Waste Collection
  - Over the next six months all residents in the City of San Diego will begin receiving a kitchen pail for in-home food scrap collection and a green bin.
  - The delivered new green bin will be placed on the street, next to the curb, in front of the your residence.
  - Food scraps, food-soiled paper such as pizza boxes, and yard trimmings can all be discarded in the green bin for weekly collection on the same day as the customer's regularly scheduled trash collection day and normal collection location.
  - Residents can exchange their delivered green bin for a different size or request additional green bins.
  - Please allow one business day after receiving the delivered container before requesting a green bin exchange for a different size or an additional green bin.
  - All green bin requests can be submitted on the [Get It Done](#) or by calling 858-694-7000.
  - Green bin deliveries will continue citywide and are scheduled based on a customer's current trash collection day.
