  - *In December Councilmember Campillo brought forward a resolution to City Council to declare a behavioral health bed crisis in the city of San Diego.*
  - *Last week, Councilmember Campillo brought forward another resolution to Council asking the City to formally support the Proposition 1 ballot measure on the March ballot.*
  - *The Resolution was unanimously supported by the entire City Council, Law Enforcement, and Mayor Gloria.*
