  - 1- reported stolen vehicle.
  - o 1- stolen vehicle found recovered in Tierrasanta.
  - o 2- vehicles had items stolen out of them. Both vehicles were left unlocked.
  - 3- reported vehicle accidents. More vehicle accidents occurred but they did not require police presence.
  - 2- hit and run reports were taken. Again, this only includes vehicles that were reported to police.
  - 10- burglary alarms. Some were to repeat homes. Reminder that homeowners with faulty home alarms will receive a fine from the city for multiple police responses.
  - 10 disturbing the peace. These radio calls also include calls of domestic violence and noise complaints.
  - Overall this shows a decline in radio calls in the Tierrasanta neighborhood.
     Hopefully, this continues. Reminder that Halloween season is amongst us, and this sometimes means an increase in reported stolen decorations. Be mindful of what you have and please report stolen decorations. You might not be the only victim!

    - There are 52 planters along the wall that need new plants.
    - o Recommend removal of brick enclosures on Antigua and Remora.
    - Residents have attached a fence to the wall.
      - Code enforcement would have to get those removed
      - First a design for the wall would be necessary
  - Medians need attention.
    - Irrigation issues
    - Need to be sprayed for pests
    - Need trimming and raking
  - Friends of Tierrasanta Canyon have lost their permit.
    - Canyonlands cut off all their friends groups
    - We can no longer legally enter the canyons to do work.
    - It is suggested to request a ranger to oversee the work being completed in the canyon.
